

## AFFIDAVIT

"Fearing for my safety, I immediately turned to retreat back into my house. Before I could reach the door, Jason grabbed my arm. We pushed and pulled as I tried to break free. "While I was on the ground, Jason grabbed my cell phone out of my hand. He smashed the phone and threw it into my swimming pool, which prevented me from calling 911 for emergency assistance.
